Special Instructions regarding merit list declared for various posts.

1. This merit list is provisional and prepared according to the given factual data in application submitted on website and hard copy via Registered A.D. to KCG.
2. In case if candidate find mistake in data or calculation given in the merit list, as per declared scheme, he/she must communicate within two days through email on recruitment.kcg1718@gmail.com with proof. Appropriate answer will be given before finalization of merit list.
3. The final merit list will be published on 01/08/2017 Tuesday before 7.00 pm. After declaration no change shall be entertained in the final merit list in any circumstances.
4. Out of total merit list only six times i.e. for Head of Initiative-78, Programme Officer-270, Project Executive-300, IT Manager-06, Legal Officer-18 candidates in order of merit will be called for written test, as per annexure.
5. Candidates scoring 60% of marks in written test shall only be eligible for Group Discussion and Personal Interview, only these candidates will be considered qualified.
6. The Final Merit List of Candidates eligible for appointment on the respective post will be prepared on the basis of overall merit including Group Discussion and Interview marks, as per scheme.
7. All candidates must write Examination **Seat Number as declared with Final merit list, against the name.**
8. The candidates who have not submitted necessary documents i.e. leaving Certificate, Graduation and Post-Graduation Mark-sheet and Degree Certificate, Experience Certificates as per the instructions given on the website are required to submit the same to KCG on or before 31/07/2017 at 5.00 pm without fail. If the candidate fails to send the documents, his/her candidature for any post is liable to be cancelled.

9. For all post, Applicants who do not possess education qualification as per the Minimum Qualification mentioned in Annexure 1 for related post/s, are not qualified for that related post. Candidature for such post of the applicant will not be considered.

But such candidate may be eligible for other post if they possess Minimum Qualification mentioned in Annexure 1 and included in merit list.


10. Table-1 to 6 has been made as per the details mentioned in point num. 9. And the applicants are not valid for such post as mentioned in the list with reasons.

11. The list declared has been made as per the overall merit of the applicant. But the minimum qualification for each post is different. So from this General List, Merit List will be prepared as per the declared posts and declared educational qualifications. And this final Merit list will be prepared as per the Educational qualification mentioned in Annexure-1.

So mere appearance of name in the provisional overall merit list, the applicant will not be considered for final selection in merit. Final merit list will be prepared as per the declared posts and declared educational qualifications (eg. 13, 45, 50, 1, 3) and 6 times of the declared posts will be called for Written Examination.
